## **NATIONAL**

#### Centre releases GST dues to states and UT's

- The **Ministry of Finance** today released an amount of **Rs 40,000 crore** to the States and UTs with Legislature under the **back-to-back loan facility** to meet the shortfall in **GST Compensation.**
- The total amount released in the current financial year as back to back loan in-lieu of GST compensation has reached to **Rs1,15,000 crore.**
- This amount of **Rs 1.59 lakh** crore to be provided to States as back to back loan would be over and above the compensation in excess of **Rs 1 lakh crore (based on cess collection)** that is estimated to be released to States/UTs with Legislature during the current financial year.
- All eligible States and UTs (with Legislature) have agreed to the arrangements of funding of the compensation shortfall under the back-to-back loan facility.
- The release of assistance under the back-to-back loan facility during FY 2021-22 of Rs 1,15,000 crore, which is more than 72 percent of the total estimated shortfall for the entire year.
- The balance amount will be released in due course.
- So far **Karnataka** has recived the maximum shortfall of GST compensation among other states, which sums up to **Rs 4,555 crore**.

#### Heaviest propellent tank delivered to ISRO

- The heaviest semi cryogenic propellent tank named SC120-LOX manufactured by Hindustan Aeronatics Limited(HAL) has been delivered to the Indian Space Research organisation ISRO.
- This was developed to replace the existing **L110** stage used in **MK-III** launch vehicle.
- The semi cryogenic- **Liquid Oxygen Tank(LOX)** is a part of **SC120** aimed to enhance the payload capabilities.
- HAL have totaaly delivered **224** propellant tank and **95** water tanks to ISRO for the space programms of PSLV, GSLV MK-II, GSLV MK-II of **diameter 2.1, 2.8** and **4 meters**, and its **length** varies from **2.5** meters to **8 meters**.

Additional Fact: HAL has delivered the biggest cryogenic liquid hydrogen tank named C32-LH2 of 4 meter diameter and 8 meter length last year.

## Sixth Edition of 'Exercise AJEYA WARRIOR' has commenced

- India-UK Joint company level military training has been commenced at Chaubatia In Uttarkhand to be held from Oct 07 to Oct 20.
- The exercise is part of an initiative to develop inter-operability and sharing expertise with friendly foreign nations.
- Indian Army and an equivalent strength from UK Army would be sharing their experiences gained during the conduct of various military operations in their respective countries and during overseas engagements.
- The joint military training would culminate with a grueling 48 hours exercise to validate the performance of both the Armies in conducting joint military operations in a semi-urban environment.
- This joint military training will go a long way in improving bilateral relations and also will be a major step towards further strengthening the traditional bond of friendship between the two Nations.

# 46<sup>th</sup> U.S India Buisness Council meeting (USIBC) held

- Commerce, Industry and textile minister addressed the 46<sup>th</sup> meeting of U.S India Buisness Council meeting (USIBC) and the India Ideas summit.
- The discussion was focussed to strengthen the strategic partnership between India and U.S.

#### The summit will include

- 1. Powering the global economic recovery in the post-COVID world.
- 2. Discussions with key Ministers on healthcare innovation in Indian states.
- 3. Fireside chats with industry officials on startups and emerging technology to tackle COVID and the "new" normal.
- 4. Breakout sessions with government officials, moderated by industry leaders on healthcare collaboration during the pandemic.
- 5. Governments' collaboration and the business community's support to mobilize new programs and resources in both countries.

## SSB and Armed police force of Nepal to conduct joint patrols

- Sashastra Seema Bal(SSB) of India and Armed Police Force Of Nepal have concluded to conduct joint patrols to control trans border crimes.
- ullet This was decided after the ullet annual coordination meeting between India and Nepal.
- The **Director general** of SSB led by **Kumar Rajesh Chandra** and **Inspector general of Armed Police** force **Shailendra Kanal** participated in the meeting.

## India retains its GDP growth forecast: World Bank

- The **World Bank** has retained June forecast for India's Gdp to grow by **8.3%** in the fiscal year2021-2022.
- The economy saw an increase in public investment to support domestic demand and

- schemes like production linked incentives to boost manufacturing.
- Over the next two years, as the base effect fades and growth is expected to stabilise at around 7%.
